## **ELIGIBILITY CRITERIA AND GENERAL INSTRUCTIONS**

- Applicant should be an Indian resident and a KVO from the 52-42 villages.
- KVO students from ALL OVER INDIA can apply.
- Applicants flying abroad for further studies (students pursuing undergrad/masters abroad). are eligible to apply.
- Moral Code of Conduct should be observed.
- Online process will be conducted only for students residing outside Mumbai (Mumbai includes area upto Virar, Kasara, Karjat, Panvel)

## **GROUP-WISE CRITERIA**

### **GROUP A - CLASS 10**

To be eligible to participate in this group the Applicant should have cleared/ passed the Std. 10 board exams in the year 2023 (SSC/ICSE/CBSE/IGCSE/IB Boards).

### **GROUP - CLASS 12/ Diploma**

To be eligible to participate in this group the Applicant should have **cleared/ passed the Std. 12 board exams/ Diploma in the year 2023** (HSC/IBDP/ISC Boards).

### **GROUP C - GRADUATION**

To be eligible to participate in this group the Applicant should have **completed/ passed a Graduate degree course in the year 2023.** 

- Example: B.A., B.Com., B.Sc., MBBS, BDS, B. Arch, Law, B. PTh, B. OTh, B.Tech, B. Pharm etc. (List is illustrative not exhaustive)
- Additionally, **students from medical fields** should have completed their respective Internships between 1st March 2023 and 7th August 2023.

### **GROUP D - POST GRADUATION**

To be eligible to participate in this group the Applicant should have

completed/ passed a Post- Graduate degree course or Masters program in the year 2023.

• Example: M.A., M.Com., M.Sc., M.Tech. M. D, M.S., etc.), Post Graduate Diplomas, CA, CS, ICWA, PhDs, super specialities (medical field) or any other higher degree etc. (List is illustrative not exhaustive)

\*LNMA ID for every registration is a unique number. It will be used to identify your application throughout the process instead of your name.\*



**Documents to be kept ready in the format specified below** (link of the form given at the end of this document)

#### Scanned photograph to be uploaded:

- In JPG/JPEG/PNG format (photo should be not older than 3 months)
- The digital size of the file should between 50kb and 1mb.

Scanned copies of 10th/12th/final year Graduation/Post Graduation marksheets, latest competitive/ entrance exam marksheet (as applicable) should be uploaded in PDF format.

- Each PDF document should be of less than 1 MB.
- For 10/12/G/PG mark sheets, name the PDF document as -FIRST and LAST NAME underscore(\_) 10/12/GRAD/PG.
  Example: VIDHIDEDHIA\_10/ VIDHIDEDHIA\_G
- For competitive/entrance exam mark sheets, name the PDF document as-FIRST and LAST NAME underscore(\_) name of the exam Example: VIDHIDEDHIA\_NEET/ VIDHIDEDHIA\_Olympiad
- Link for compressing/merging the pdf: <u>https://smallpdf.com</u>
- Please ensure that all the data you enter in the online form is authentic and true. In case any data is found false, the application stands void immediately.
- Please ensure that the scanned uploaded documents are **readable**. If the uploaded documents are not readable then they will be considered as **invalid** and the applicant shall bear complete responsibility for the same.
- All official communication of LNMA 2023 will be via email. Please add LNMA2023@DDKF.ORG to the safe list and keep checking your mailbox for emails

The entire LNMA 2023 process will be conducted offline on the respective event days at Nappoo Hall, Matunga CR or at a venue to be informed in due course. For students studying outside Mumbai, across India/abroad, the LNMA 2023 process will be conducted online. (Mumbai includes area upto Virar, Kasara, Karjat, Panvel)

This provision of online process is subject to verification and only at the discretion of the DDKF Managing Committee members in-charge of LNMA 2023 process.
